Fee Schedule

For Civil and Criminal Appearances:

**Santa Clara County:**  
(exceptions below) San Jose, Santa Clara, Palo Alto, Morgan Hill. \$75 / ½ hour -

Matters Requiring Juvenile Court, Federal Court, Argument of Motions, Pleas, \$150 / hour -  
Special Handling: “First In Line” Matters, Ex Parte, Family Court, etc. 1 hour minimum

Note: in addition to time at court, time billed will include time spent reviewing documents and in consultation with attorney of record and/or client(s) represented.

**All Other Counties:** \$150 / hour-  
1 hour minimum

**Additional Fees:**

Rush Fee – Appearance information must be received at our office and receipt acknowledged at least one half business day prior to appearances in Santa Clara County, and one full business day prior to appearances in all other locations or special handling matters. \$25

Pick Up Discovery – Pick-up of discovery during appearance, that has been paid for prior to appearance, for your client that we are appearing to represent, and in that department. (Pick-up of discovery anywhere other than the department during the appearance must be scheduled as a separate appearance.) \$25  
Includes shipping via Priority Mail Flat Rate Envelope.

Cancellation Fees – Cancellation of appearance less than one full business day prior to appearance (unless situation below applies). \$25

Cancellation of appearance after the appearing attorney has altered their calendar to accommodate the appearance, or after the appearing attorney has already begun travel to the appearance and has no other cases scheduled in that court. 2/3 of appearance fee

Our appearance attorneys will always endeavor to complete your appearance expeditiously to keep the fee to a minimum, but matters beyond an attorneys control may cause things to run longer, such as: Time required for appearing attorney to consult with attorney of record; Review of necessary documents; Time spent waiting for interpreters or codefendants; or Judges who will not hear cases out of order.

Payment in full is due upon receipt – we invoice promptly by email and issue monthly billing statements. Returned check fee is \$25. We do accept credit cards - Visa and Master Card preferred. Charges over 30 days past due are subject to finance charges of 18% APR calculated daily and billed monthly.
